HOUSE BILL 144 (H.B. 144)

In 2002, the Utah State Legislature passed H.B. 144, a law that allows qualifying undocumented students (with and without DACA) to be considered for **in-state tuition**, the same tuition rate as Utah residents, if the student enrolls in a public Utah college or university and meets the following criteria:

H.B. 144 Requirements:

Student **MUST** have...

- Attended a Utah high school for three (3) or more years;
- Graduated from a Utah high school or attained the equivalent to a Utah high school diploma (e.g., GED);
- Registered for college after 2002;
- Have filed an application to legalize their immigration status or be willing to file an application when they become eligible;
- Student cannot be living in the U.S. on a current visa (e.g., tourist or work);
- Submit the H.B. 144 Affidavit to each public Utah college or university they attend.

H.B. 144 Benefits:

- H.B. 144 students pay **in-state tuition** (\$)
- All public Utah colleges and universities accept H.B. 144

H.B. 144 Facts:

- Each public Utah college and university has their own version of the H.B. 144 Affidavit.
- H.B. 144 students cannot be considered for federal student aid (i.e., FAFSA)



SENATE BILL 253 (S.B. 253)

Under S.B. 253 (2015), any student who graduates from a Utah high school (regardless of high school graduation year) is **NOT** required to provide proof of lawful U.S. presence to be awarded privately funded scholarships in public Utah colleges and universities. Therefore, regardless if the student has or does not have DACA, as long as they have graduated from a Utah high school, they may apply to privately funded scholarships administered by their college or university.

S.B. 253 Requirements:

- Graduate from a Utah high school.

S.B. 253 Benefits:

- Allows undocumented students (with and without DACA) to apply for privately funded scholarships.



DEFERRED ACTION FOR CHILDHOOD ARRIVALS

Deferred Action for Childhood Arrivals (DACA) Facts:

- DACA recipients **do not** qualify for federal student aid (i.e., FAFSA)
- DACA is not the Dream Act / Green Card
- Federal decisions regarding the future of DACA are separate from H.B. 144 and S.B. 253 in the state of Utah.

APPLYING TO THE U!

Incoming freshman applying to the University of Utah must complete the Common Application. Undocumented students (with and without DACA) will be classified as international students and pay the international admissions application fee. Applicants may request an application fee waiver through the Common App.
